

## HOW TO COMPETE IN THE HB SURF SERIES 2006

- If you are **under 18** years of age, a **parent or guardian** must also read and **sign** the Membership, Entry and Hold Harmless Form. (Both signatures are required to surf!)
- Your entry form must reach the HB Surf Series office by Wednesday before the event.** (will not accept mailed entry after wednesday!)
- Beach entries are cash only** (money order accepted)
- There are no refunds.** If you miss your heat you can be placed as a 2nd alternate.
- Transfers are only permitted if you contact the HB Surf Series 1 week before the event date you would like to be transferred from. If the event is rescheduled, entries will automatically be transferred to the next event.
- Competitors age is determined as of 12:00 am January 1st of 2006. You must provide proof of age (drivers license or birth cert.) with your Entry Form.
- It is the competitors responsibility to know and understand the HB Surf Series 2006 rules and regulations. (posted at each event & hbsurseries.com)
- If you bounce a check, you will be required to pay HB Surf Series in cash or money order \$20.00 fee, plus the amount of the check that bounced. Future payments will only be accepted with cash or money order only!
- Each event starts approximately at 7am. Check in at contest site at least 1 hour before the scheduled start of your heat in case the schedule has changed.
- The HB Surf Series is not responsible for lost mail.
- Go to hbsurseries.com the night before the event for "approximate division times"**.
- No Phone or Faxed entries excepted!

## Hold Harmless, Release Form

### Release, Covenant, Waiver and Indemnity

Agrees to never institute any Claim, as defined below, against Huntington Beach Surf Series ("HB Surf Series"), its owners, affiliates, and its predecessors, successors, assigns, and the agents of each of them (the "Released Parties") and releases and holds the Released Parties harmless from any and all known and unknown claims (including attorneys' fees and costs), including wrongful death, whether or not liability is alleged to arise from any tortious conduct of the Released Parties, or any of them ("Claim" or "Claims") and which arose or arise from Participant's participation in the HB Surf Series (the "Series") or association with the Released Parties. Participant does hereby agree to indemnify, defend and hold the Released Parties harmless from and against any and all Claims arising out of Participant's participation in the Series or association with the Released Parties.

Participant and Guardian, if applicable, further agree(s) and acknowledge(s) that there is a risk that subsequent to signing this document, Participant will discover or suffer unknown or unanticipated Claims. Participant and Guardian, if applicable, acknowledge(s) and agree(s) that this release applies to all Claims. Participant and Guardian, if applicable, expressly waive(s) Section 1542 of the California Civil Code, which reads as follows:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor." Participant and Guardian, if applicable, represent(s) and warrant(s) that Participant is familiar with the risks and dangers involved in participating in the Series. Participant hereby fully assumes any and all responsibilities and liabilities for such risks. PARTICIPANT VOLUNTARILY ELECTS TO ACCEPT ALL RISKS connected with Participant's participation in the Series.

Participant and Guardian, if applicable, assign(s) to HB Surf Series, its successors and assigns, all of Participant's right, title and interest in or to all films, photographs and negatives thereof, recordings, tapes, publicity or the like (whether taken or made by HB Surf Series or its representative or Participant or his/her agents, and delivered to HB Surf Series) ("Publicity") which may be taken during or result from Participant's participation at the Series all of which shall become the exclusive property of HB Surf Series. Participant hereby acknowledges and agrees that HB Surf Series may use such Publicity as HB Surf Series deems fit or proper without any further consent of Participant and without compensation to Participant, and Participant and Guardian waive(s) any and all rights to residual monies which may be derived there from.
